As a whole, the SAB acts as a consulting and advisory Board to affect and impact on the implementation of specific parts of the project and to provide a final evaluation of the project outputs.

Stakeholder Boards has been created (under coordination of HCA) between M2 and M6. In each partner country, 5 stakeholder panels have been formed, including representatives from CRFS initiatives (SMEs, NGOs, unions), public administrators and policy makers (PAs), school committee, researchers (HEIs) and representatives of the civil society (e.g. individuals, food councils, consumer organisations). First version of the panels will be compiled by M8 (D3.2) and then updated at M24 (D3.3), M36 (D3.4) and M48 (D3.5).

Each panel will promote initiatives within T3.1.3. (MyLocalFoodE Initiative) and will take part in the codesign of priorities and regulations that will be adopted in the open challenge for pilot design and implementation (T4.3).

Regarding school committee, in particular, it will include all the schools that will host the KidScience activity. Thanks to KidScience activity, school pupils will be engaged in the MyLocalFoodE initiative by attending open-science events with researchers and food systems managers, presenting sustainable CRFS concepts and developing innovative pioneering strategies for implementing innovative food systems in their regions. Pupils will be involved in school competitions, challenges, hackathons, etc.

The reimbursement of costs of the Stakeholder Board members for participating to MyLocalFoodE initiatives will be covered directly by the partner. That partner's budget will be adjusted by UNIBO accordingly in order to include these costs in the partner's budget if reported and accepted by the EC.

# **Eco Logic portfolio**

NGO Eco Logic was founded in February 2014. Since the early days of the organization we have been developing programs on continuous and long-term sustainable development through the concept of urban gardening, incorporating urban gardens as infrastructural elements of sustainable cities and education through the areas of ecology and sustainable development. The first project is known to the public as the "Ekologika Garden – from the garden to the city", while our second project "School garden" is currently in the fourth year of its realization, and so far has been carried out in three elementary schools in Montenegro: "Dragiša Ivanović" and "Sutjeska" in Podgorica, and "Vuko Jovović" in Danilovgrad. Therefore, today we can proudly say that we are better recognized for our projects than for the name of the NGO that stands behind them.

# 1. Ekologika Garden - from the garden to the city

The project started in 2014. Its launch was funded by the Fund for active citizenship (FAKT) and Rockefeller Foundation, which enabled us to successfully the first phase of the project. It makes us happy that we are headed towards accomplishing the complete sustainability of the project. Its focus is creating concepts of urban gardens as specific models of infrastructure withing sustainable cities of the future, as well as introducing community gardening initiatives as new transitional ways of citizen gathering. The concept of urban gardens is based on principles of sustainability, local economy, ecological balance, environment protection, and citizen activism. The guide in our practice is the paradigm of permaculture as ecological design which mediates the relationship of the human community towards the (limited) natural resources our species has at its disposal.

### 1.1. A free-of-charge service to the community

Over the last four years, the "Ekologika Garden" project has been – and still is – an accessible and free service for all citizens who want to tap into the world of urban gardening; to educate themselves and experiment with the possibilities and benefits this model has to offer. So far, the project has been realized on the locality of Mareza, not far away from Podgorica. More than fifty people took active participation and embraced their roles in the project. Also, extramural users, their families, friends, and interested citizens had the chance to take part and learn about this relatively new trend in sustainable urban development. To top it all off, we opened the doors of the space which was the designated location for this project for the free use by the pupils from several kindergartens and elementary

schools. As a pioneer project, the Ekologika Garden is interesting to other non-governmental organizations as well, especially those from the field of ecology. We successfully collaborated with the Scout Association Njegoš from Podgorica, International School of Practical Philosophy "Nova Akropola", providing them with the space to implement some parts of their projects; as well as with the Nature and Gorica Lovers Association, elementary school "Dr Dragiša Ivanović" and vocational high school "Spasoje Raspopović", with whom we have shared our knowledge of the fields of ecology, urban gardening, and permaculture. Through certain segments of the project, we have established the collaboration with the Ministry of agriculture, NGO Expeditio and the Petrović Njegoš foundation.

# 1.2. Volunteerism

Aside from our citizens, the Ekologika Garden has been a host to the volunteers from abroad who were interested in the ecological direction we represent. We take pride in hosting volunteers from all over the world – from New Zealand, over the Middle East, to Central and Western Europe, and North America, and representing Montenegro as an ecological state with all its potentials the right way. Besides the dimensions that deal with promoting inclusiveness, volunteerism, and philanthropy, this project also has the component of self-sustainability, which enables the activities to continue and improve year after year. # 2. "Eko Atlas" – platform for geolocating, mapping, and keeping records of the reforested and already existing trees

"Eko Atlas", the project which was launched at the end of 2017, was the logical upgrade of the "Ekologika Garden" concept, directed towards revitalization of urban, suburban and wider city area. That segment of "Ekologika Garden" comprises of agroforestry, method which implies combining agricultural and forest managerial techniques to create dynamic ecosystems and abundant biodiversity, as well as to preserve the authentic landscape and agricultural land, which is an indispensable resource in healthy food production. For a country such as ours, which is ecological in principle, that has to be set as an imperative. On the road towards broadening the scope of reforestation activities, we aim at utilizing the comfort of the use of modern technologies to enable citizens to take active participation in this project, both individually and in collective activities that contribute to restoration of wood stock as well as to mapping the current state, which would make it easier to control the plant stock in the city in the future, and prevent non-planned and illegal cutting of trees on the outskirts of the city.

Fall 2019 marked the beginning of a new dimension of Eko Atlas. Through collaboration with EU Info Center in Montenegro on their green campaign "Budi primjer, uključi se!" (engl. "Be an example, take

part!") we have given away dozens of oak tree seedlings we had grown ourselves, and organized reforestation activities in a number of locations around Montenegro.

# 3. Project "School Garden in Elementary School Dr Dragiša Ivanović"

Led by the idea of creating a sustainable school tied to the concept of urban gardens, this project resulted in the development of the first school garden in Montenegro. School gardens are "open classrooms" which use all the (often unused) potential of the school and school property intending to broaden educational possibilities without leaving the schoolyard. The project's goal is to integrate school with the local community, raise ecological awareness among pupils, initiate ecological activities and promulgate informing on ecological topics among students. That is successfully being carried out through educational workshops on the topics of sustainability, energy efficiency, space estimation, environmental protection, permaculture, and through organizing ecological activities in the community, such as getting the students' parents, as well as the local community, volunteers and other civil society entities involved in the Ekologika Garden and in creating the school garden and contents for it.

Over the course of five years, about 1200 elementary school students and 300 kindergarten pupils (who attended the modified version of the program) attended the program lectures. The project is still being implemented. It has been supported by the Petrović Njegoš Foundation since Day 1. The Ministry of Agriculture supported the project during the school year 2017-2018. The Ministry of Education approved the project for each school year so far. Also, last year, as part of the program "Škola i grad/SCHOOL4CITY" which was launched by NGO "Expeditio – Centre for sustainable spatial development" from Kotor, in collaboration with the Institute for Education and organization "JAS - Jugend Architektur Stadt", our project has also been carried out in these elementary schools: "Sutjeska" and "Vuko Jovović"; while within the collaboration with the Municipality of Ulcinj it has also been brought about in elementary school "Maršal Tito".
